Finance News...

The City of Linton has issued *Street Improvement Project Special Assessments* to property owners in the city. Our church has been notified that the assessment for the church property is \$10,473.65, and the parsonage \$5,236.82. This is payable in 10 installments over a 10 year period, and will be included in the annual property tax statement. Interest will be assessed on the unpaid principal balance at an annual rate of 3.75%. The first installments due are for the church, \$1,047.37; and the parsonage, \$523.68. County tax deadlines and penalties apply. At the Council meeting on November 11th it was decided to pay the special assessments from the city of Linton over ten years. Please be mindful of this added expense when considering your offerings and contributions to our church.

The Navajo Evangelical Lutheran Mission

More than fifty years ago Lutheran Christian missionaries arrived in Rock Point, AZ, a remote, isolated village near the Four Corners area where Arizona, New Mexico, Colorado and Utah meet. They were leased 5 acres of land on which to build the Mission.

The Navajo Evangelical Lutheran Mission (NELM) exists today to connect diverse communities to the needs of the Navajo People by creating a safe environment where the values of education, culture, and spiritual formation are accessible to all people.



According to their core values followers of Christ, NELM strives for reconciliation and healing in a broken world. They work for justice and peace, in accordance with the teachings of Jesus, in the power of the Holy Spirit.

Other values include:

- Serving and supporting the community through cultural sensitivity, open communication, and love for all.
- Applying the highest level of ethical standards by being financially and morally accountable to
- Providing the best possible education and community services in an efficient and effective manner.
- Working with the Rock Point community to assist residents in creating a socially and economically sustainable community.

Core Beliefs include:

- We believe that all people are children of God.
- We believe that the Navajo People are our sisters and brothers; our neighbors.
- We believe that when our neighbors hurt, we hurt, and we are led to care.
- We believe that service grows out of community, and we are committed to partnership with the Navajo People in that ministry of service.



Proposed Bylaw on Christian Marriage

At the August 12th, 2015 Church Council meeting, the council approved the following addition to the bylaws to be presented to the congregation at the Congregational Assembly in January, 2016. The proposed bylaw was formed in response to the Supreme Court's ruling on marriage on June 26th, 2015 with the aid of the LCMC. "We affirm the LCMC's Pastoral Admonition which states,

"We affirm that God created us male and female, and that it is God's will and intention that human sexual expression and fulfillment take place only within the boundaries of marriage between one man and one woman (Genesis 2:24-25; Matthew 19:4-6; and Mark 10:2-9). And, we confess as individuals and as congregations that we have not fulfilled God's will in our decisions, modeling and teaching."

"This Congregation also affirms and holds as its own the faith statement on Marriage and Family as published by Lutheran Core which states;

"We believe and confess that the marriage of male and female is an institution created and blessed by God. From marriage, God forms families to serve as the building blocks of all human civilization and community. We teach and practice that sexual activity belongs exclusively within the biblical boundaries of a faithful marriage between one man and one woman."

"Consistent with the above stated convictions regarding a Scriptural view of marriage, this Congregation;

- A) Will only recognize, participate in, solemnize, and host weddings between one man and one woman.
- B) Prohibits the use of its facilities for all weddings, unions, blessings of sexual relationships, and for receptions or celebrations of weddings or other unions in which the Congregation's called pastor(s) is not primarily and directly involved. Any usage of the facility should be consistent with the Congregation's stated beliefs.
- C) Requires that it's called pastor(s) conform to the Congregation's convictions as stated above when undertaking pastoral acts outside of the congregation."

Proposed changes to the Constitution and Bylaws For December 20th, 2015 Special Meeting of the Congregation

Found below are all the original statements and the proposed changes. In the proposed changes, the part that differs is highlighted.

Proposed Changes to the Constitution:

Amendments to the constitution require a majority vote of those present and voting at a properly called congregational meeting for approval. They are then to be ratified at an annual meeting of the congregation by a two-thirds vote of those present and voting. See C17.02 in the Constitution.

C1.01

Original: "The name of this congregation shall be <u>Peace Lutheran Church of Linton.</u> **Change:** "The name of this congregation shall be <u>Peace Lutheran Church of Linton, North Dakota.</u>

C11.01

Original: "The officers of this congregation shall be a president, vice-president, secretary and treasurer."

Change: "The officers of this congregation shall be a president, vice-president, secretary/treasurer."

C11.02

Original: "The Congregation shall elect its officers and they shall be the officers of the Congregation. The officers shall serve for one year or until their successors are elected. Their terms shall begin at the close of the annual meeting at which they are elected."

Change: "The Congregation shall elect its officers and they shall be the officers of the Congregation. The officers shall serve for three year terms or until their successors are elected. Their terms shall begin at the close of the annual meeting at which they are elected."

C12.02

Original: "The members of the Congregation Council except the pastor(s) shall be elected by the congregation to serve for _3_ years or until their successors are elected. Such members shall be eligible to serve no more than one full term. No member of the Congregation Council shall succeed themselves on the Congregation Council. An unexpired term of one year or less shall not be considered a full term of office. Their terms shall begin at the close of the annual meeting at which they are elected."

Change: "The members of the Congregation Council except the pastor(s) shall be elected by the congregation to serve for _3_ years or until their successors are elected. Following the three year term, if there is a council vacancy due to health, death or injury reasons, an outgoing council member may be appointed to fulfill the remainder of the term by the current council. At

the end of ANY term of duties, each council member shall abstain from a council position for the length of one calendar year to allow other and more members of the congregation to have the opportunity to serve our church."

C13.04

Original: "When a pastoral vacancy occurs, a **Call Committee** of six voting members shall be appointed by the Congregation Council. Term of office will terminate at installation of the newly-called pastor."

Change: "When a pastoral vacancy occurs, a **Call Committee** of six voting members shall be appointed by the Congregation Council. Term of office will terminate at installation of the newly-called pastor. Call committee members should not be spouses or family members of congregational council."

C14.01

Original: "All organizations within this congregation, with Congregation Council approval shall exist to aid it in ministering to the members of this congregation and to all persons who can be reached with the Gospel of Christ. As outgrowths and expressions of this congregation's life, the organizations are subject to its oversight and direction. This organization at its meeting shall determine their policies, guide their activities, and receive reports concerning their membership, work, and finances."

Change: "All organizations within this congregation, with Congregation Council approval shall exist to aid it in ministering to the members of this congregation and to all persons who can be reached with the Gospel of Christ. The organizations are subject to its oversight and direction of the congregational council. This organization at its meeting shall determine their policies, guide their activities, and receive reports concerning their membership, work, and finances."

Proposed Changes to the Bylaws:

Bylaws may be adopted or amended at any legally called meeting of this congregation with a quorum present by a majority vote of those voting members present and voting (C16.02 of the Constitution.)

B1.02: Reference in the second paragraph (b) changed from "Section A.4" to "B1.01 Paragraph 4."

B3.03

Original: Meetings of the Congregation Council shall be held on the third Wednesday of the month, unless otherwise specified in the church bulletin.

Change: Meetings of the Congregation Council shall be held on the second Wednesday of the month, unless otherwise specified in the church bulletin.

B3.04

Original: Committees of the Congregation Council

- a. One (1) trustee shall be in charge of the stewardship and evangelism committees of the congregation.
- b. Two (2) trustees shall be in charge of property and its management.
- c. One (1) deacon shall be in charge of parish education.
- d. Two (2) deacons shall be in charge of worship.

Change: Committees of the Congregation Council

- a. One (1) council member shall be in charge of stewardship.
- b. One (1) council member shall be in charge of evangelism committees of the congregation.
- c. Two (2) council members shall be in charge of property and its management.
- d. One (1) council member shall be in charge of parish education.
- e. Two (2) council members shall be in charge of worship.

B3.09 (paragraph 2)

Original: Buildings which are the property of the congregation shall not be lent or rented to any group or individual not affiliated with the congregation or with Lutheran Congregations in Mission for Christ unless application for such use has been approved by the Congregation Council.

Change: Buildings which are the property of the congregation shall not be lent or rented to any group or individual not affiliated with the congregation or with Lutheran Congregations in Mission for Christ unless application for such use has been approved by the Congregation Council. REFER TO CHURCH USAGE PAMPHLET.

The following are proposed changes to the descriptions of duties of various committees of the church.

Addition: "Support Pastor in maintaining education classes for youth, families, and adult members, etc."

Removed: 13. Maintain church email correspondence with Pastor.

Added (at the end): Refer to the wedding guidelines booklet.
